

ORDINANCE # 221

AN ORDINANCE TO EXTEND THE CORPORATE LIMITS OF THE CITY OF HATTON AND ANNEXING A TRACT OF LAND DESCRIBED AS FOLLOWS:


All that portion of Lot B of the Southwest Quarter (SW $\frac{1}{4}$) of Section Seven (7), Township One Hundred Forty-eight (148) North, Range Fifty-three (53) West, according to the County Auditor's Plat thereof filed in the office of the Register of Deeds of Traill County, North Dakota, in Book "A" of Plats on page 59, lying South of a line parallel to and 660 feet North of the section line common to Sections Seven (7) and Eighteen (18), Township One Hundred Forty-eight (148) North, Range Fifty-three (53) West, except that portion thereof previously conveyed to the Great Northern Railway Company by Warranty Deed dated December 7, 1960, and recorded in the office of the Register of Deeds, Traill County, North Dakota on December 14, 1960, at 1:10 p.m. in Book "58" of Deeds on page 353.

BE IT ORDAINED, by the City Council of the City of Hatton:

SECTION 1. The City of Hatton in the County of Traill, North Dakota, is a municipality and is incorporated under the laws of the State of North Dakota.

SECTION 2. That the corporate boundary of the City of Hatton be extended to include, annex, and incorporate within the City of Hatton the above described real estate.
